THE PURPOSE OF THE DEVEREUX FOUNDATION IS TO PROVIDE HIGH-QUALITY HUMAN SERVICES TO CHILDREN, ADULTS, AND FAMILIES WITH SPECIAL NEEDS WHICH DERIVE FROM BEHAVIORAL, PSYCHOLOGICAL, INTELLECTUAL OR NEUROLOGICAL IMPAIRMENTS.
