The company incubated new work at their home in San Francisco, and produced collaborative shared programs across different artistic disciplines. The company presents original works at prestigious venues across the nation and internationally, engages distinguished collaborators, continues to develop a unique recognizable aesthetic, and values artistic risk-taking in all of its endeavors. LEVYdance regularly conducts master classes and holds residencies at universities on the West and East coasts.
