The Studios for the Performing Arts Operating Company is a collaboration comprised of four Sacramento nonprofit performing arts groups The focus of the project is to provide shared space for rehearsals and offices and allow for expanded educational opportunities The campaign to raise funds for a jointly-managed building was kicked off in 2007 with the intentions of building a four-story 47,000 square feet structure located at the corner of 14th and H Streets in Sacramento Since then, the campaign has shifted to the lease and re-purposing of a school on 24th and N Streets the Fremont School The renovation and management of this campus is through a partnership with the Sacramento City Unified School District, the City of Sacramento and the Studios for the Performing Arts Company During the fiscal year 2013-14, one of the original partners, California Musical Theatre, exited the company due to changing priorities and needs During the first six months of 2014, further work was conducted in accessing the structural needs of the facility, working with engineering and construction companies to develop the plans and timetables Preliminary budgets and business plans were developed Potential arts-related tenants were identified Continuing discussions with the City of Sacramento were conducted and reports prepared for review and updates with City staff
