**First:** Name of Corporation: The Cleveland Foundry

**Second:** Location of Principal Office in Ohio: Cleveland, Cuyahoga County, Ohio.

**Third:** Purpose for which the corporation is formed:

The Cleveland Foundry is organized and will be operated exclusively for religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States federal tax code, including without limiting the generality of the foregoing, the following:

- a) To receive and maintain a fund or funds and to expend the income and principal thereof in support of the corporation's activities, programs and facilities;
- b) To create, establish or finance funds, financial support, grants, endowments, fellowships, scholarship incentives, and awards as the Directors of the corporation deem appropriate from time to time to assist individuals and groups;
- c) To take and hold by bequest, devise, gift, purchase, or lease either absolutely or in trust, for any of its purposes, any property, real or personal, without limitation as to amount or value; to sell, convey and dispose of any such property and to invest the income and principal thereof, and to deal with and expend the income and principal of the corporation for any of the purposes hereinbefore set forth;
- d) To undertake the foregoing activities and generally to carry on either alone or in cooperation with others any and all activities in furtherance of one or more of the said purposes; and
- e) To do and to perform all acts reasonably necessary to effect the foregoing purposes in such manner and at such times as the Directors of the corporation determine.

**Sixth:** The Corporation shall not discriminate against any person on the grounds of race, color, gender, religion, disability, sexual orientation, or national origin.
