Antioch University is a bold and enduring source of innovation in higher education serving nearly 4,000 adult students around the world and across the country, online and from its five campuses in four states, in addition to its University-wide international and doctoral programs. Each campus offers degree programs that meet-and often anticipate-the pressing needs of its region and the wider world. During Fiscal Year 2015 (July 1, 2014 to June 30, 2015), Antioch University Connected launched, providing online delivery for bachelor's and master's programs. This initiative, along with new partnership agreements with the Peace Corps, helped Antioch reach new students and new markets. In addition, Antioch University continues to participate in three national programs that are exploring higher education models for the future. Through a competitive process, the Competency-Based Education Network (C-BEN) accepted Antioch University as one of 18 higher-education institutions and two major systems to address common challenges in designing and developing competency-based degree programs and related business models. Second, the University was accepted into the second cohort of institutions to participate in the Higher Learning Commission's Academy on Student Persistence and Completion. Through the Academy, Antioch University will build its capacity to improve students' persistence and completion in their undergraduate degree programs by focusing on effective collection of data, evaluation and improvement of current strategies, and the development of new strategies. Third, through Next Generation Learning Challenges, Antioch University is joining eight other colleges and universities to form incubator teams that will re-think education and business models as they consider competency-based program development. The University completed consolidation of services and offices to reduce redundancy, and now has one payroll office, one University Registrar, one University Director of Financial Aid, one Vice Chancellor of Institutional Advancement, and one Office of Institutional Effectiveness, and shared learning objectives for a majority of our programs across the University. The creation of one modern IT system continues on time and on budget, with all of the Business Process Modeling completed and new modules slated to roll out in Fiscal Year 16

At June 30, 2015 and 2014, there were no unrecognized tax benefits identified or recorded as liabilities. The University files Forms 990 and 990-T in the U.S. federal jurisdiction and the required states. With few exceptions, the University is no longer subject to examination by the Internal Revenue Service for years before 2011.
