By an amendment to its Articles of Incorporation, filed and effective November 19, 2014, Kentucky Center for the Arts Foundation, Inc. (the "Foundation") removed the Kentucky Department of the Arts (a unit of the Commonwealth of Kentucky), Fund for the Arts, Inc., and J.B. Speed Art Museum as potential supported organizations of the Foundation and named Kentucky Center for the Arts Corporation (the "Corporation") as its remaining sole supported organization. The Foundation did so (i) because it had not provided and did not intend to provide support to organizations other than the Corporation and (ii) in order to establish its status as a functionally integrated Type III supporting organization within the meaning of section 4943(f)(5) of the Internal Revenue Code and §1.509(a)-4(i)(4) of the Federal Income Tax Regulations and, more specifically, that the Foundation qualifies for such status under Section 3.01 of IRS Notice 2014-14, 2014-2 I.R.B. 274, by supporting only the Corporation, a governmental entity within the meaning of that Notice. By letter dated February 26, 2015, the IRS determined that the Foundation qualified for such status.

The Executive Committees of the Corporation and the Foundation meet jointly at least six times a year. The Audit Committees of the Corporation and the Foundation meet jointly twice a year. The Governance Committees of the Corporation and the Foundation meet jointly three or four times a year. The directors of the Foundation thus maintain a close and continuous working relationship with the directors of the Corporation.

The President of the Corporation is a member of the Board of Directors, Executive Committee, and Investment Committee of the Foundation and the Vice Chair of the Foundation. The President and the Chief Financial Officer of the Corporation attend the meetings of the Boards of Directors, Executive Committees, Audit Committees, and Investment Committees of both the Corporation and the Foundation. Officers of the Foundation thus maintain a close and continuous working relationship with the directors of the Corporation.

The Foundation's Investment Policy Statement provides that the President of the Corporation shall be a member of the Investment Committee of the Foundation, that the Committee may delegate investment functions to officers and employees of the Corporation, and that the Chair of the Committee and the Chief Financial Officer of the Corporation are responsible for deciding whether to call the Committee into session.
