**Domestic Violence Prevention and Treatment** - Establishes quality assurance standards for the operation of all domestic violence programs statewide, coordinates 12 peer reviews, and provides technical assistance and support to reviewed programs. Conducted events, disseminated public service announcements and press releases, and provided information via the organization's website. Conducted an annual statewide conference for domestic violence professionals and responded to over 2,750 requests for technical assistance from member programs, public and private agencies, and victims. Continued Indiana's statewide primary prevention initiative, including a five-year plan to reduce risk and increase protection for youth.

**Direct Services** - The legal resource project provides legal representation and direct service advocacy to low income victims of domestic violence and stalking. Direct services were provided to approximately 2,210 victims of domestic violence, including legal assistance and advocacy, crisis counseling, and information and referral. The legal resource project provided direct legal assistance to approximately 290 victims of domestic violence who sought assistance in filing/enforcing protective orders, child custody and divorce cases, immigration, and landlord-tenant disputes. The legal resource project also provides legal technical assistance to approximately 480 domestic violence programs with client issues, confidentiality, subpoenas, statute interpretation, and general legal

**Training and Coordination** - Provided training and education throughout the State of Indiana to approximately 3,100 professionals statewide, and distributed over 41,700 pieces of educational materials. Activities included 10 training sessions per month, an annual conference, a Batterers Intervention Institute, and other programs designed to reach law enforcement, judicial and probation personnel. Provided for coordination and collaboration with all federal, state, and local entities to improve system response and victim services.

Professional accounting standards require ICADV to recognize a tax liability only if it is more likely than not the tax position would be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount of tax liability that is greater than 50% likely of being realized on examination. For tax positions not meeting the more-likely-than-not test, no tax liability is recorded. ICADV has examined this issue and has determined that there are no material contingent tax liabilities or questionable tax positions. Tax years ending after 2011 are open to audit for both federal and state purposes.
