The Organization works with a network of food donors, social service organizations and churches to provide food to hungry people in its nine county service area. Delivering nearly 13 million pounds of food annually to the northeast corner of the state requires coordination and commitment. Feeding 21,100 hungry people a week also requires funding for every step of the process—from acquiring food, to safe food storage, to transportation of that food to over 400 member agencies. With a modest budget, Community Harvest successfully completes the complex process of delivering food to children, families and seniors and serves as a model for other food banks not only around the United States but around the world.

Community Cupboard allows our member agencies to directly refer clients to this "mom & pop" style grocery store for food assistance. Those referred clients can shop for everything their family needs including: fresh fruits and vegetables, meat, canned food, cereal, spices, flour, sugar, dairy products, cleaning supplies, paper goods, personal hygiene products, vitamins, and more. The program was able to distribute over 1.8 million pounds of food in FY 2015.

Kids Cafe® is a safe place where kids at risk can go for a hot meal prepared and served by volunteers and youth program staff with food provided by Community Harvest Food Bank.

Kids Cafe®, a program of Feeding America, is one of the nation's largest free meal service programs for children. Since the program's inception in 1993, Kids Cafes have become an important tool in our efforts to end childhood hunger.
