The Association of Notre Dame Clubs, Inc. - Staten Island (supporting organization) maintains a close and continuous working relationship with the University of Notre Dame du Lac primarily via Clubs' volunteer staff, University alumni management personnel, and both regional directors and the national alumni board of directors. The contact with officers of the clubs is maintained by staff through proactive outreach based on election cycles of each individual club, on-boarding new officers, ongoing contact and support via phone, email, and social media, as well as formal reporting of club activity on an annual basis. Club support is maintained through active outreach on the part of the University to the Clubs through regular periodic update sessions made available to the Club as well as frequent contact initiated by Club officers to the Association.
