Safe Housing Project and Leadership Development (SHP/LD)-Community Alliance of Tenants (CAT)
organizers and volunteers have organized and built the leadership of 385 tenant leaders in
Portland. Renters were experiencing issues ranging from no heat, mold, broken locks, mice,
roaches, broken kitchen appliances, and interior water damage. They also experienced issues
related to fair housing and displacement, including discrimination, language and cultural
barriers. They have been working with groups that are historically under represented; refugee
communities that speak Nepali, Burmese, Zomi and Karen. Tenants worked together to write
collective letters, learn about their rights and develop their skills and leadership within
their own communities.

4b (Code:) (Expenses \$ 121,079 including grants of \$) (Revenue \$)

Tenant Education Program (TEP)-The Renters' Rights Hotline served over 2500 tenant callers,
getting much needed information to callers in crisis, on how to best self-advocate for their
rights. The TEP also is responsible for educational outreach in the community, giving renters
rights presentations to at risk renters who benefit greatly from understanding their rights
and responsibilities as renters. In 2014 CAT through EP has given 21 community presentations
and educational information to over 430 renters in Portland, East Multnomah County and
Washington County. Additionally, we have given 3 landlord/tenant law trainings to volunteers
so that they have the ability to answer calls on the hotline. Trained over 58 English and/or
Spanish speaking volunteers on the hotline. We started new programs, to help tenants write
letters to their landlord, and to support tenants with an evictions court date. The highest
call trends were eviction, repairs, and non payment of rent.

Housing Justice Program (HJP)-In collaboration with JOIN, StreetRoots, Oregon Food Bank,
Oregon Opportunity Network, and the Coalition of Communities of Color, CAT launched the
highly successful Welcome Home Coalition, to build a housing justice movement and advocate
for new affordable housing revenue on metro Portland. CAT is a member of the statewide
Housing Alliance. 2014 was a year to organize for Housing Opportunity Agenda, and we won \$8
million in increased Landlord-Tenant Coalition. CAT successfully negotiated with landlords to
require more transparency and accountability for landlords who bill tenants for utilities.
