All Others The UMB Foundation manages and invests private gifts and/or property for the benefit of the University of Maryland in Baltimore (UMB), facilitates fundraising programs and contributions from private sources, and engages in other activities to further educational, research and service missions of UMB UMB is Maryland's public academic health and law university devoted to professional and graduate education, research, patient care, and public service UMB includes the Schools of Medicine, Law, Pharmacy, Dentistry, Nursing, Public Health, and Social Work, the Health Sciences & Human Services Library Using state-of-the-art technological support, UMB educates leaders in health care delivery, biomedical sciences, social services, and law By conducting internationally recognized collaborative research to cure disease and to improve the health, social functioning and treatment of the people it serves, the university fosters economic development in the city, state and region UMB is a major employer in Baltimore, generating \$15 in economic activity for every \$1 of state general funds invested in FY 2015 UMB was awarded over \$499.6 million in research and grant funding

Medicine The UMB Foundation supports academic programs, clinical activities and research in the University of Maryland School of Medicine (UMSOM). Established in 1807, UMSOM is the first public and fifth oldest medical school in the U.S. and the first to institute a residency training program. In 2015, the UMSOM graduated a total of 356 students with medical, allied health or graduate degrees. Of the graduating students, 155 received their medical degrees and joined the ranks of more than 8,000 living alumni. A significant number, 46-percent, have chosen to continue their training in primary care fields. This past year, the UMSOM admitted another class of students with exceptional academic credentials, which included 159 new medical students and another 66 students in medical graduate programs. A leader in biomedical research, the UMSOM secured more than \$402 million in grants and contract support in FY2015. According to the latest data from the Association of American Medical Colleges, the UMSOM ranks 8th among all 86 public medical schools and 23rd among all 144 public and private medical schools in terms of grant and contract expenditures. More than half of the practicing physicians in Maryland receive their training at the UMSOM or its clinical partner, the University of Maryland Medical Center. The UMSOM is committed to the education and training of MD, PhD, graduate, physical therapy and rehabilitation science and medical research technology students.

Law The UMB Foundation supports academic programs and clinical and research activities in the University of Maryland Francis King Carey School of Law (Maryland Carey Law). Established in 1816, Maryland Carey Law began regular instruction in 1824. It is the third oldest law school in the nation. The innovative academic and specialty programs have garnered national and international recognition. The Maryland Carey Law's experiential programs are among the most extensive in the country, including the nationally ranked Clinical Law Program, which offers more than 100,000 hours of free legal services to the state of Maryland and has been in existence for more than 40 years. Interdisciplinary specialty programs are offered in environmental law and law and health care. Other programs include advocacy, alternative dispute resolution, business law, intellectual property law and international and comparative law. The Maryland Carey Law seeks to promote a more just society by educating outstanding lawyers and leaders, advance the understanding of law and legal institutions and enhance access to justice. Excellence in teaching prepares students for leadership and professional success in a wide range of careers and promotes in both students and faculty the highest standard of public and professional service.
