Orphan Care- Shaohannah's Hope is dedicated to participating in orphan care projects that address the holistic needs of orphans- physically, emotionally, and spiritually with the ultimate goal of helping place the child in the best permanent situation possible, ideally a family. In recent years, the Organization has focused their direct orphan care efforts in china by creating "show hope special care centers" including manas big house of hope, a 6-story 60,000 square foot facility in luoyang, china, designed to care for over 120 special needs orphans with medical impairments. there are five show hope special care centers.

Adoption Assistance- Shaohannah's Hope is actively involved in providing waiting orphans with loving families by financially assisting adoptive couples through adoption grants. During the this reporting period the Organization authorized more than 495 awards to adoptive families' adoption agencies and over \$2,270,000 in funds were distributed on behalf of more than 495 adoptive families. Furthermore, the organization provides resources and conference opportunities to all adoptive parents who are challenged by issues that are unique to some adoptive children in an interest to help shape a connected adopted culture.
