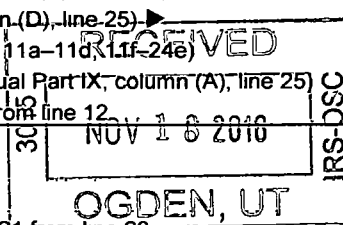

The Wild Bird Fund Center opened June 2012 in a beautiful Landmark storefront at 565 Columbus Avenue. That first year we treated 1,500 patients. In 2015, the patient load grew to over 3,500. As word of our work spreads, more and more caring New Yorkers come to us bird in hand. To meet the growing demand we leased the adjoining storefront to create a Wildlife ER, which will have an operating room with recovery cages, an X-ray facility and intensive care units for large animals. 150 volunteers work at the Center and four avian and exotic veterinarians consult.

In the center's educational theater we offer continuing education for licensed wildlife rehabilitators, presentations on emergency care of wildlife for school children and the general public, and talks on the birds of New York City by informed speakers and authors. During migration season there are walks and talks in Central Park for bird watchers and photographers. WBF is a regular presenter at the American Museum of Natural History, the New York Historical Society and Central Park Conservancy. An 8 month core curriculum on birds and the environment is taught in the public schools, while private and public schools visit the center or are visited by WBF educators.
