In the past year CCHO had directly served 134 children in our foster care and residential treatment programs. The vast majority of these children have been impacted by many episodes of trauma in their lives. Our therapists and case managers directly served 1152 children and adults, providing over 21,000 hours of mental health treatment. Our Encompass Adoptin program completed 6 child adoptions. Poplar Ridge Adventures, including our climbing tower, ropes course, work groups and team-building exercises, served 1200 people with over 5000 volunteer hours. Poplar Ridge Stables, our equine therapy program, provided direct service to 107 clients.
