ICAN's Housing Program consists of 27 properties that are owned, managed and maintained by ICAN. The property units range from efficiency units to multi-bedroom single homes. Most are scattered site multi-family units. ICAN operates two properties with contracted on-site staff, one group home for (8) individuals whose disabilities have rendered them unable to live fully independent, the other staffed property is specialized housing operated as a "safe haven", modeled on "housing first" concept, which houses (20) chronically homeless individuals diagnosed with severe mental illness, but who have not embraced services of the mental health system to manage their illness. (ICAN's Housing program accomplishments continued on Schedule O, page 1.)

ICAN administers several Rent Subsidy Programs for clients who prefer greater independence and participates in programs that prevent homelessness. In these programs, clients choose private market apartments within fair market rent limits. ICAN collaborates with landlords willing to understand our clients, who agree to accept rent vouchers and work with care providers to provide housing stability. These subsidy programs provide a wide array of rental and utility assistance, both transitional and permanent. (ICAN's Rent Subsidy program accomplishments continued on Schedule O, page 2.)

Shelter and street dwellers come to ICAN for basic necessities of living, such as food vouchers, emergency housing, clothing, bus passes, and toiletries. Our Homeless Outreach Program staff coordinate the services of community resource providers to meet individuals' unique needs. ICAN provides the only street outreach service to the homeless community in our county. Our outreach program maintains a "drop-in" center for clients that serves as a daytime refuge from weather elements, provides a place for socializing, as well as a meeting place with referral specialists for 945 individuals.(ICAN's Homeless Outreach program accomplishments continued on Schedule O, page 2.)

The typical client served by ICAN's Housing program is an individual who was homeless at the time he entered ICAN housing, and has been diagnosed with a major mental illness. Eligibility is dependent on income level (below 35% of average median income) and history of homelessness. Numerous units have rental subsidies, with residents paying a portion of their income toward the controlled fair market rent (no more than 40%, including utilities). During the fiscal period, 144 formerly homeless individuals were housed in ICAN properties, totaling 36,922 days. The tenants have been in their units for an average of 2.5 years. The personnel responsible for the management of the property guide clients through the leasing process, the maintenance staff have the range of skills to make most repairs and make certain our units meet safety and quality standards. ICAN's Housing Support Specialists assist ICAN tenants to follow lease obligations and learn good neighboring skills. They help residents make the difficult transition from street survival to becoming productive citizens through a combination of scheduled trainings, tenant association meetings, and personal home visits. Over 135 residents received personal visits, over 1,185 hours were spent engaging residents directly. Since 2011, ICAN has a task force that focuses on the affordable housing needs specifically for veterans. This initiative resulted in the Agency being deeded five newly renovated homes that were targeted in neighborhoods with above average foreclosure rates, designed to provide affordable housing for veteran families that fall below 80% adjusted median income, by Stark County Development Dept. Six veteran families were provided affordable housing by ICAN during the period. During the fiscal period, this program received \$3,952 of in-kind donations.
