1 Briefly describe the organization's mission: The Ignatian Solidarity Network (ISN) is a national social justice organization inspired by the spirituality of St. Ignatius of Loyola. ISN was founded in 2004 and is a lay-led 501(c)(3) organization working in partnership with Jesuit universities, high schools, and parishes, along with many other Catholic institutions and social justice partners.

4a (Code: ) (Expenses \$ 108,369 including grants of \$ ) (Revenue \$ ) Human Rights Issue Education, Social Action & Advocacy Programs: The 17th Ignatian family Teach-In for Justice in Washington, D.C. on November 15-17, 2014 was another occasion for ISN to celebrate martyrs' lives - this time with over 1,500 members of the Ignatian Family. At the Teach-In, ISN also hosted the premiere of "Blood in the Backyard," (now titled "Blood of the Martyrs"), a compelling documentary from Loyola Productions about the social and political environment in El Salvador that led to the murders of the Jesuits and the two women, and why their deaths continue to matter today. (continued on Schedule O).

4b (Code: ) (Expenses \$ 102,406 including grants of \$ ) (Revenue \$ ) Faith-Based Leadership Development and Affirmation. ISN hosted two leadership summits for high school students and faculty. Named after the late Pedro Arrupe, S.J., former leader of the Jesuits internationally, the Arrupe Summits offer students and teachers the opportunity to explore the relationship between service, social justice, faith, and leadership. In total, nearly 100 students from Jesuit high schools across the U.S. participated in the two summits held in California and Maryland. In June, 2015, ISN welcomed 28 immersion experience coordinators from Jesuit and partner Catholic universities for a 3-day/2-night conference on the integration of Ignatian spirituality into faith-based immersion experience domestic and international programs. 4c (Code: ) (Expenses \$ 133,765 including grants of \$ ) (Revenue \$ ) The Ignatian Solidarity Network continues to grow its available content for students, parish members, faculty, staff and others related to faith and social justice at www.ignatiansolidarity.net. In 2014-2015, ISN saw a 200% growth in unique visits. In addition, significant growth occurred in engagement via social media, with similar growth to Facebook and Twitter networks over the course of the year.

martyrs' work for justice in conjunction with present-day human rights issues in El Salvador, staying in homes and meeting with community members, NGO leaders and Jesuits. During ISN's Ignatian Family Advocacy Month (IFAM) in February, students, faculty, staff and parishioners from our nationwide member institutions advocated for environmental justice, immigration reform, and humane U.S. policy toward Central America. Advocacy efforts ranged from in-district Congressional office visits to gathering signatures for the Catholic Climate Covenant's, St. Francis Pledge.

Form 990, Part III, Line 4a (continued from above). In total, over 4,000 people across the country participated in IFAM 2015. In July, 2014, ISN led another effort in which 1,200 alumni of Jesuit universities and high schools sent a letter to Jesuit-educated members of the U.S. House of Representatives, calling on them to "seek comprehensive immigration reform without delay." The 43 Congressional members, who included former House Speaker John Boehner (Xavier University '77), attended one or more of the 28 universities and 60 high schools sponsored by the Society of Jesus (the Jesuits) in the United States. Citing the "Jesuit spirit of generous service to people in need and a persevering commitment to the common good," the letter called for immigration reform that includes a process for earned citizenship for the undocumented, respect for the rights of workers, preservation and protection of family unity and human dignity, and the restoration of fairness and accountability to the U.S. immigration system.

Form 990, Part III, Line 4b (continued) ISN recognized Sr. Carol Keehan, D.C. with the Robert M. Holstein Award. Named after the late ISN co-founder Bob Holstein, the award honors those who have demonstrated a significant commitment to leadership in social justice. Previous award winners include Fr. Jim Connor, S.J., Fr. Charlie Currie, S.J., Fr. Stephen Privett, S.J., Fr. Donald MacMillan, S.J., and Sr. Helen Prejean, C.S.J. ISN marked the 25th anniversary by establishing the "Legacy of the Martyrs" award. Three recipients were chosen in 2014-2015 for their leadership and service in the spirit of the Jesuit martyrs and their companions. Award winners included Rep. Jim McGovern, a strong advocate of U.S. policy that honors human rights in El Salvador and across the globe, Equipo de Reflexion, Investigacion y Comunicacion (ERIC) and Radio Progreso, a Jesuit-sponsored organization in Honduras whose work
