THE HABITAT FOR HUMANITY OF INDIANA'S AMERICORPS PROGRAM RECRUITS MEMBERS TO SERVE AS VOLUNTEER COORDINATORS, CONSTRUCTION ASSISTANTS, FAMILY SERVICES COORDINATORS, AND ASSIST IN SPECIAL PROJECTS AT AFFILIATE ORGANIZATIONS THROUGHOUT THE STATE. THE PROGRAM REQUIRES A COMMITMENT FROM MEMBERS TO COMPLETE BETWEEN 450 AND 1,700 HOURS OF SERVICE. THE ORGANIZATION COORDINATED THE APPLICATION PROCESS AND POSITION AND HOST SITE MATCHING DURING THE FISCAL YEAR.

THE ORGANIZATION PROVIDED SUPPORT TO NEARLY 65 AFFILIATE ORGANIZATIONS THROUGHOUT THE STATE OF INDIANA. THIS SUPPORT IS USED FOR CONSTRUCTION MATERIALS AND THE COORDINATION OF THOUSANDS OF VOLUNTEER HOURS TO CONSTRUCT SIMPLE, DECENT, AFFORDABLE HOUSING IN PARTNERSHIP WITH LOW INCOME FAMILIES OF INDIANA. DURING THE FISCAL YEAR, THE ORGANIZATION ALSO CONDUCTED A RESEARCH PROJECT AND FEASIBILITY STUDY AS PART OF A CAPACITY BUILDING INITIATIVE IN CONJUNCTION WITH THE ORGANIZATION'S 30 YEAR ANNIVERSARY.
