The Teen Parenting Initiative Program (TPI) is a school-based birth to age 3 preventive program that provides comprehensive social service to teen parents and their young children TPI is currently serving over 400 teen-head families The program operates four days a week at seven different Chicago public high schools which include the following high schools Robeson, located in the Englewood community, Hyde Park, located in the Hyde Park community, Julian High School, located in south Chicago, Simeon, located in West Chatham, John Hope High School, located in south Chicago, Farragut, located in the Little Village community, and Simpson, located in the Little Village community TPI aims to prevent teen parents from dropping out of high school, while preventing secondary teen pregnancies and reducing the incidence of child maltreatment for their young children It also promotes school readiness for at-risk children
