As a condition of employment, the president of Elmhurst College is required to reside at the residence that also serves as a venue to carry out regular college business including entertainment of trustees, employees, students, donors, and guests of the College. IRS Form 990 instructions require that the fair market value of housing provided to employees be reported on Form 990, Part VII, Section A and Schedule J, Part II. For tax year 2015, the value of the residence is conservatively estimated to be \$61,630. The College has determined that the value of the housing is not considered taxable income to the President as provided for in Internal Revenue Code Section 119. During tax year 2015, the President, Stephen Alan Ray made the residence his home for the year. Schedule J, Part II, Column (D) includes \$61,630 of value associated with the use of the residence provided by the College.
