Behavior modification, counseling, and other supportive approaches are used to help students develop the necessary skills to return to their home school. For the year ended June 30, 2015, 3,570 child days of service were provided to 31 students.**4b** (Code:) (Expenses \$ 640,354 including grants of \$) (Revenue \$)GroundworkA domestic violence program for battered women and their children. Program provides emergency shelter, counseling, and social services. The shelter is open 365 days per year, 24 hours per day. Prevention education is offered in schools, businesses, and community organizations.
