Lung Health Programs Reduce the burden of chronic disease (especially asthma, lung cancer, and COPD) We use health educators and other trained staff/volunteers to educate communities about how they can address lung health disparities and educate individuals about how to manage their lung disease Currently, our programs and projects include Fight Asthma Now (for youth/teens), Asthma Management (for caregivers), Asthma-Friendly Childcare Project (for early childcare providers), Addressing Asthma in Northern Lake County Project, COPD Initiative including our Living Better Together COPD Conference, Healthy Lungs Initiative, and Radon Awareness efforts among others

Tobacco Control Reduce smoking rate, reduce exposure to secondhand smoke and prevent youth from using tobacco In 2015, Respiratory Health Association worked with Chicago Public Schools on a project aimed at decreasing the smoking rate and exposure to secondhand smoke among Chicago Public Schools students In addition, the Healthy Lungs Initiative, in collaboration with the Cook County Health and Hospitals System, provides direct counseling and other resources to smokers who want to quit Through partnerships with the city and county, as well as with private businesses and other local health departments and hospitals, Respiratory Health Association provides "Courage to Quit" smoking cessation classes and "Intro to Tobacco-Free Living" workshops for adults, as well as the "Operation Storefront" curriculum encourages youth to make the choice to stay tobacco-free In addition, Respiratory Health Association partners with health departments and other community stakeholders to promote smoke-free environments, including smoke-free housing These programmatic efforts are complemented by several policy initiatives to increase smoke free environments (including parks) and to resist efforts to create exemptions in the Illinois Clean Indoor Air Law, which we helped pass in 2007

Environmental Health Promote policies that improve indoor and outdoor air quality and raise awareness about how air pollution affects lung health In 2015 we supported educational/awareness activities to limit idling by diesel vehicles and equipment and urged medical institutions and freight businesses to require the use of cleaner diesel construction equipment We also worked to limit pollution by coal-fired power plants throughout Illinois and supported local health regulations for petroleum coke storage We called for action to reduce air pollution from transit vehicles, including diesel buses and locomotives, and initiated community-based awareness activities to inform local residents about risks to their lung health State lawmakers were asked to support limiting toxic materials and fix existing renewable energy and energy efficiency programs Federal lawmakers were asked protect Clean Air Act programs and support strategies to address global warming and clean energy
