The President/CEO recuses herself from any discussions regarding the setting of her own compensation. The independent firm uses market surveys and other resources to compare the compensation of IES Abroad vice presidents and officers and positions to similar (or identical) positions at other organizations with similar annual revenues, comparable annual enrollments, comparable numbers of employees, and comparable levels and complexities of job responsibilities, in order to establish a benchmark for reasonable compensation. IES Abroad most recently retained an outside compensation review firm for the vice president's and other officers' (including President/CEO) compensation in April 2014. The overarching goal of IES Abroad's compensation policy is designed to achieve compensation levels for its vice presidents and officers at competitive market rates. It is Board policy to define competitive market rates at the 65th percentile (vice presidents, except Marketing), the 75th percentile (EVP of Marketing), and 85th percentile (President/CEO) of the market salary by position as determined by national surveys. Annually, IES reviews the performance of each of its vice presidents and officers. The Human Resources Department annually monitors salaries of all headquarters, U.S. based employees based upon the review of several national, 3rd party compensation survey reports. Once approved by the Board Executive Committee on an annual basis, compensation decisions made by the Executive Committee for vice presidents are presented to the full board of directors. Separately, the Executive Committee of the Board recommends compensation for the President/CEO to the full Board that in turn votes on the President's/CEO's compensation. The full Board votes on the compensation of the President/CEO on an annual basis. Vice presidents and officers never take part in the discussions regarding the setting of their own compensation. The chair of the Board of Directors documents the above process to the department of Human Resources on an annual basis. The compensation package of some of the organization's vice presidents and officers are documented in a written employment contract.
