CMDA's Global Health Outreach ministry (GHO) coordinated 44 short-term medical, dental and surgical mission trips to developing countries this year, with approximately 1,036 qualified volunteers seeing an average of 65,000 patients yearly. GHO combines evangelistic outreach with desperately needed healthcare to demonstrate the love and compassion of Christ in a material way. National doctors in needy countries are also invited to join our teams and learn new techniques/information as our physicians, nurses, dentists and other medical personnel share their knowledge and faith.

CMDA's Medical Education International program (MEI) is a short-term missions program that sends teams to teach in international academic or clinical settings to bring transformation by advancing medical, dental, bioethical and educational knowledge while sharing the gospel. MEI accomplished this goal this year through the services of 192 volunteers

Regional Campus and Community Ministries:
CMDA staff and members support and serve in a variety of activities on campus (for healthcare students) and in local communities (for graduate physician, dentists and other healthcare professionals). These include Bible studies, prayer breakfasts, sharing groups, conferences and service projects. CMDA has campus ministries on 266 healthcare campuses, with an average of more than 12,000 students participating, including medical, dental, physician assistant, nursing and other students. Regional Directors, Area Directors, Associate Staff, Faculty Advisors and training student leaders oversee these activities. Each year, more than 2,500 members volunteer in one of the many CMDA outreach programs.

Conferences and Seminars:
CMDA seeks to encourage, train and equip Christian healthcare professionals and students in their professional lives by providing conferences on evangelism, marriage, bioethical issues, women in healthcare, family and more. National conventions and regional seminars allow members to network with colleagues, hear renowned Christian speakers and discuss professional and spiritual issues. CMDA is approved to offer Category 1 Continuing Medical Education (CME) for physicians, as well as Continuing Dental Education (CDE) for dentists. CMDA offers continuing medical and dental educational credits in the USA and on some GHO and MEI mission trips, as well as in an annual overseas conference for missionaries and national doctors to provide their required yearly continuing education requirements which may have been difficult for the missionaries to otherwise obtain.

ICMDA – CMDA pays dues to the International Christian Medical & Dental Associations (ICMDA). The goals of the ICMDA are: 1) to deepen the spiritual life of Christians practicing in the medical and dental professions worldwide, and to encourage them to share their faith within their national professions. (2) To provide a regular means of exchanging views, information, and experience in the fields of medicine and dentistry, especially where these concern Christian faith and ethics. 3) To promote fellowship and cooperation among Christian doctors and dentists throughout the world.

CMDE – money transferred to pay for the annual CMDE conference. The CMDE conference is designed for physicians, dentists, and public health professionals serving in mission agencies-institutions-clinics outside of North America. The educational goal of the conference is to provide state of the art updating and review of modern medicine with Category I credit for physicians as well as dental education credit. Priority registration is given to American physicians, dentists, nurses, and ancillary personnel who are living and serving in missions abroad until a registration cutoff date at which time registration is open to any physician, dentist, nurse, and ancillary medical personnel who are living and serving in missions abroad as long as they are sponsored by a CMDA member.

PAACS (Pan African Academy of Christian Surgeons) offers specialty training in general surgery in Africa to African physicians. The training centers are located at selected rural Christian Hospitals on the continent that are known for the quality of their surgical services and are directed by experienced, board-certified general surgeons.

Part I – CMDA currently has a foreign national director of medical missions in Nicaragua. This person is paid a stipend and expenses to coordinate CMDA's medical missions work in various countries of Central America.

Schedule F and Form 990 Part IX, Line 3: These amounts do not agree in large part due to the fact that many of the expenses from wired funds for medical missions or medical training are categorized into the other functional expense lines. This is done by foreign recipient submitting an expense report upon the completion of the mission/training.
