In fiscal year 2015 approximately \$666,422 was given by 1,204 donors The top program benefiting from these contributions was JRMC Oncology project Oncology care is a new service JRMC is offering in our region and is scheduled to begin patient treatment in November or December of 2015 There are 109 "known" patients in our direct service area, representing 828 infusions and 75,000 saved travel miles, who could benefit annually from this growth service In our 60 mile service radius, the estimated number of patients more than doubles to 252 Gifts totaling \$201,916 from 144 donors launched Phase 1, Service Initiation in our journey to oncology Twenty-three supporters contributed 42 gifts totaling \$97,656 benefiting our Building and Campus Fund These gifts are comprised primarily of final pledge payments for pledges received during our New Hospital Campaign This campaign supported our new medical center which opened in 2010 Gifts numbering 196 from 44 supporters provided \$114,952 to our endowment fund Strategically, efforts to secure endowed funds will continue to increase as sustainability and independence have been designated as priority goals by our governing board
