IPHCA provided training, maintenance, and software support services for the Illinois Primary Health Care Association's integrated Practice Management/Electronic Health Record/Electronic Dental Record system that 13 Federally Qualified Health Centers with delivery sites in medically underserved areas utilized during the year IPHCA ceased these program operations effective February 1, 2015 The goal of the network was to allow participating health centers to continue the services they provided to their community while realizing significant cost savings and benefits as a result of being part of a collaboration The network facilitated further integration and use of new technologies to enhance communication, trust, and renewed working relationships between diverse health center partners The network helped foster a working environment among health center partners, allowing for the free exchange of ideas and information between entities hundreds of miles away Finally, it created additional commonality among partners and eliminated old excuses for not working together on common ground issues

IPHCA provides training and technical assistance (T/TA) to potential and existing health centers, including its membership who operate nearly 350 sites, through a cooperative agreement with the Health Resources and Services Administration (HRSA) Through this agreement, IPHCA conducts various statewide/regional T/TA activities to assist potential and existing health centers meet Heath Center Program requirements and improve organizational performance

In a cooperative agreement with the Illinois Department of Public Health (IDPH) Office of Policy, Planning, and Statistics, IPHCA conducts recruitment visits to health professions training programs and schools to encourage employment in Community Health Centers (CHCs) and promote the National Health Service Corp (NHSC) and educate health profession students about loan repayment and scholarship opportunities IPHCA also works with IDPH to gather data, evaluate, prepare and submit shortage designation applications for Health Professional Shortage Areas and Medically Underserved Areas/Populations which are used in conjunction with NHSC and grant awards respectively During the last grant period, IPHCA successfully recruited 60 clinicians into CHC sites
