In fiscal year 2014, PFund’s grantmaking program awarded grants and stipends totaling \$175,925 to 26 lesbian, gay, bisexual, transgender and allied 501c3 nonprofits, programs or collaborations in the Upper Midwest (Minnesota, Iowa, North Dakota, South Dakota and Wisconsin) PFund’s support enables grant recipients to build power through community, advance equality and increase access, safety and security for LGBT and allied people Grantee partners received support for work ranging from participating in LGBT regional assessments to organizing LGBT communities of color around health justice issues to helping LGBT and allied youth develop leadership skills through theatre In fiscal year 2014, PFund awarded educational scholarships to 18 outstanding LGBT and allied student leaders, totaling \$60,000 These college and graduate students are recognized for their leadership in their schools and communities, from advocating for inclusive school climates and policies to excelling in the performing arts and educating their peers about LGBT communities In fiscal year 2014, PFund continued to raise awareness about issues in the LGBT community and help LGBT organizations and leaders connect with one another by providing multiple kinds of educational and convening opportunities Over the course of the year, PFund organized and hosted a regional convening of over 80 LGBT community leaders, a grantee and scholar recognition event, and an annual community celebration with over 140 attendees Finally, PFund honored and encouraged LGBT leadership by awarding a "power of one" award, which honors LGBT community activism and leadership and provides a \$1000 grant for the awardee to direct to the LGBT organization of their choosing
