During 2012, the Jewish Federation entered into a second agreement with Steven Nasatir which provides for annual payments of \$5,000 beginning April 1, 2015 and lasting throughout his lifetime. The \$50,000 and \$5,000 annual payment amounts are to be adjusted annually in accordance with the CPI index. These benefits are payable to him only for as long as he lives. There are no guaranteed payment amounts and no survivor benefits at his death. In 2014, Steven Nasatir received payments of \$71,976 from the first supplemental non-qualified retirement plan. David Rosen. The Jewish Federation has an agreement with David Rosen which provides for annual payments of \$25,000 per year beginning in 2018 and ending in 2028.
