The men work in uniforms, daily, in visible locations picking up trash, AND cleaning THE streets OF ATLANTA. AFTER 3 MONTHS THE MEN ARE ELIGIBLE FOR A CONTRACT JOB OPPORTUNITY WITH ONE OF GEORGIA WORKS' CORPORATE PARTNERS. CURRENTLY, APPROXIMATELY 30 COMPANIES USE GEORGIA WORKS' AS A STAFFING COMPANY FOR THEIR LABOR NEEDS. The men are taught the importance of timeliness, appearance, courtesy, respect, and care as they interact with the community AND THE STAFF AT THE CONTRACT JOBS. The men learn the necessary soft skills of employment, such as customer service and teamwork
