In Macon County, programs must provide measurable outcomes which fit into one or more of five impact areas: education, health, safety, self-sufficiency, and basic needs. Funding decisions are made by volunteers and reviewed thoroughly and approved by the Board of Directors. Agencies prepare interim reports which are reviewed by staff to make sure that the programs are achieving the outcomes expected. Every four years, the agencies must go through an endorsement process which requires them to meet 19 standards of operation. Agencies which receive designated pledge payments are researched to ensure that they are tax exempt entities entitled to receive tax deductible contributions and that they are not on any terrorist watch lists. All agencies are required to submit a Patriot Act Compliance Certification annually.
