Valley CAN is committed to improving air quality in California's San Joaquin Valley. We promote voluntary actions to reduce air pollution and sponsor pilot programs and educational efforts dedicated to providing solutions to high emissions sources.

Tune in and Tune Up: Held 23 Tune in and Tune Up events at which free emissions testing was performed for an average of 500 cars per event. Provided vouchers for up to \$500 in free emissions related repairs, and subsidized the repair of over 5,000 vehicles. Repairs resulting from one event equate to the removal of approximately 3,000 tons of carbon monoxide, 300 tons of hydrocarbons, and 150 tons of oxides of nitrogen from the air in one year.

Vehicle Replacement Program: Assisted vehicle owners in replacing old, high emitting passenger vehicles by providing down payment assistance of \$5,000. 88 high emitting vehicles were replaced through this program.

Enhanced Fleet Modernization Program/Plus Up: Assisted vehicle owners in replacing old, high emitting passenger vehicles with efficient and technologically advanced vehicles with a variety of incentives ranging from \$2,500 to \$11,500, depending on the income level of the participant and the vehicle being purchased or leased. All vehicles replaced were destroyed to ensure no future operation. 30 high emitting vehicles were destroyed and replaced with efficient vehicles.

**Public Charity Status**

On October 30, 2009, Valley CAN notified the Service that it wished to terminate its private-foundation status as of November 1, 2009, pursuant to Internal Revenue Code ("Code") Section 507(b)(1)(B), and it requested an advance ruling from the Service that it would qualify as a public charity under Code Sections 170(b)(1)(A)(vi) and 509(a)(1) on the reasonable expectation of its public support during the 60 months following that date.

As demonstrated in the attached Form 8940 recently filed, Valley CAN satisfied the requirements of Section 507(b)(1)(B), 509(a)(1), and 170(b)(1)(A)(vi) over its 60-month termination period, and had 79.60% public support for the period from November 1, 2009, through October 31, 2014, well above the 33 1/3% level at which an organization automatically qualifies as publicly supported under Code Sections 509(a)(1) and 170(b)(1)(A)(vi). As shown in the accompanying Schedule A, Valley CAN's public support percentage was 81.91% for the year ended June 30, 2015; therefore, Valley CAN believes it is a public charity and has accordingly filed a Form 990 rather than a 990 PF.

As noted in the attached letter, Valley VAN requested an extension of time to file the 990 to February 16, 2016. An extension to file a 990PF was approved instead, but we request the extension be applied to the 990 since the Organization qualifies as a public charity and the original request was timely filed.
