Each year, following a specific formula, the Pine Rest Foundation awards grants to Pine Rest Christian Mental Health Services to fund various aspects of behavioral health care and counseling programs. An award of \$631,121 was made to provide funds for financial assistance for patients with the inability to pay for services. An additional \$829,058 was made available for education, prevention, and support programs through the Hospital. Funding was provided for the continued development of a Residency Program, specifically the Outpatient Residency Clinic as the first class of recruits moves to Phase 2- Outpatient study. Funding was also provided to improve Hospital Based Services through bettering new-employee orientation and training. Funding was also provided to implement a systematic assessment of patient violence. The remaining 978,544 represents the Pine Rest Foundation's responsibility as the "single-portal" for all donations intended for the Pine Rest Foundation and Pine Rest Christian Mental Health Services "PRCMHS", the related organization.
