We provide support for persons living with mental illness and their families by providing support groups. This year we needed to train leaders for both groups. Training for Connection leaders cost \$4941 and for Family Support Group leaders cost \$614. We were reimbursed by other affiliates for providing training for their leaders as well. We also provided support through our newsletter, our telephone, supporting our national and state affiliates, and social gatherings such as the picnic and winter social for a total cost of \$3,889.

We provide educational classes for family members for a cost of \$692 fo New this year was NAMI Peer to Peer for persons living with mental illness with costs of \$3, 790. We also provided education to the community by having a Mental Illness Awareness Week as well as extensive use of the news media, had booths at various events, and supported In Our Own Voice presentations to various groups including police officers. This total was \$8,667.

We also provide advocacy for persons with mental illness and their families particularly in court situations. For this our volunteers needed training. We also support our national and state affiliates in educating legislators on the needs of persons with mental illness and our families.
