Contributions of cash, equipment and classroom supplies given to the Foundation for educational purposes were transferred to the College to enhance the programs available at Delta College and to provide additional scholarships and awards that do not have endowed support. The Foundation also used funds to publish and distribute an informational magazine featuring Delta College personal success stories, programs and opportunities available to the residents in the surrounding communities. These contributions benefitted the entire college community of approximately 16,000 students and staff and informed the residents of the Great Lakes Bay Region

4b (Code:) (Expenses \$ 1,664,352 including grants of \$ 1,664,352) (Revenue \$ 0)

Contributions to the Foundation for endowments were transferred to the College for investment in the College's Endowment Fund. Investment income generated by the Endowment Fund provided approximately 300 scholarships and awards this past year. Investment income also supported several college programs and projects such as the Possible Dream Program, Teaching Chairs and professional speaker presentations. These educational opportunities benefitted the entire Delta College community of approximately 16,000 students, faculty and staff as well as the residents in the surrounding communities who were invited to campus to attend many of our events.

Donations to the Foundation for non-academic student assistance were used to provide emergency funding to currently enrolled students to help them complete the classes they had already started. These special needs students were provided help with rent, utilities, transportation and educational supplies. This additional support beyond the classroom benefitted approximately 202 students
