WPR's mission is to serve the entire state by producing, acquiring, and delivering high quality radio programming that serves the public's need to discuss ideas and opinions and that provides cultural enrichment, intellectual stimulation, and intelligent, enlightening entertainment throughout the WPR network. WPR's most recent annual report indicates approximately 440,000 listeners per week, and over 50,000 contributors. WPR broadcasts from 33 radio stations throughout the state and also streams live online providing programs from its three networks: the Ideas Network, the NPR News and Classical Music Network, and the 24-hour HD Classical Music Network

WPT can be viewed throughout Wisconsin on its main channel, the Wisconsin channel, and on WPT Create. WPT broadcasts attract nearly 1.4 million viewers each month.
