THESE PROGRAMS AND AGENCIES RECEIVED NEARLY 1 MILLION REQUESTS FOR SERVICE THIS YEAR. SHFB PROVIDED APPROXIMATELY 12.4 MILLION MEALS DIRECTLY, VIA PARTNER AGENCIES AND PROGRAMS.

PROGRAMS INCLUDE: KIDS CAFES, SCHOOL PANTRIES, FIELD TO FOODBANK, MOBILE PANTRIES, GROCERY STORE RESCUE PROGRAM AND SNAP OUTREACH.
