Essentia Health St. Joseph's Medical Center's Board of Directors consists of 5 members of the community it serves, 1 employed physician who lives in the community, 2 members employed by an affiliated organization and the President of the organization. Essentia Health St. Joseph's Medical Center has an open medical staff, so any qualified physician of the community is allowed to apply. All applicants that apply must meet the credentialing standards and be approved by our Board of Directors in order to come and provide services in our system. Any surplus funds are reinvested into the hospital by adding new capital equipment or buildings or replacing existing capital through the annual budgeting process. The community has come together to support numerous areas to impact its health to include: 1. Development of five community gardens which impact the work of those with mental health concerns, school-aged children and volunteers who support them. 2. Utilized partnerships with University of MN extension to provide education for the garden work and its participants. 3. Developed a "3 Good Things" campaign, surrounding mental health resiliency, for schools, workplaces, and in the home of families. 3. Collaborated with local walkable/bikeable committees to provide support for way-finding signs to share community assets with those being physically active. 4. We supported and provided training assistance to the local college for a tobacco-free policy and support for those who might need cessation to help them cut down or quit tobacco use. 5. We supported breastfeeding promotion to local workplace wellness partners, as well as supported staff and patients in "Baby Friendly" recognition. 6. We supported local day care centers for developing a garden, and incorporating curriculum to their young participants to support healthy eating habits, and education supporting the garden. We also provided training assistance to them for policies that induce increased physical activity. 7. We developed a communications campaign to support overall health and wellness education throughout the community through a variety of ways: Crow Wing Energized website, Brainerd Daily Dispatch newspaper Monday Motivator, Sunday Advertisements, local billboard messaging, etc. 8. We gave out over \$70,000 to local partners to support a variety of projects including, increased physical activity, healthy eating promotion, workplace wellness best practices, and mental health initiatives or trainings to support (Adverse Childhood Experiences ACEs). 9. We supported falls prevention and evidence-based programming called "Matter of Balance" - through trainings to community volunteers and outreach and referrals for this particular class offering. 10. We supported and staffed a large community-wide approach for the evidence-based program called national diabetes prevention program. We trained 40 community leaders to become certified health coaches, and moving into FY 16 have started a collaborative effort of over 80 trained lifestyle coaches to launch a "Your Energized Year" lifestyle change challenge. 11. We supported local partner Northern Pines Mental Health by having three staff to attend a tobacco cessation professional development seminar in order for them to work on tobacco reduction and stress reduction skills in the mental health facilities. 12. We provide monthly lunch and learn opportunities to support health and wellness related topics throughout the course of the year and partnered with the local library in doing so. Essentia Health St. Joseph's Medical Center is a part of Essentia Health, a fully integrated health system with facilities in Minnesota, Wisconsin, North Dakota and Idaho. As a non-profit organization, Essentia Health reinvests surplus revenues into medical training, programs and technology that improve patient care. Essentia Health provides services predominantly in rural communities and is committed to eliminating geographic barriers to care. We strive to provide high-quality, patient-centered care close to home for the communities we serve. We continue to upgrade facilities and technology, such as MRIs, CT scanners and surgery suites, to ensure patients in rural communities have nearby access to these services. In addition, we have recently completed several major construction projects, which include a new \$50 million wing for our Fargo hospital and several rural community clinics. Essentia Health was one of the first Accountable Care Organizations in the country to receive the highest level of accreditation from the National Committee for Quality Assurance (NCQA). Essentia Health St. Joseph's Medical Center is part of Essentia Health, an integrated health system with 16 hospitals, 68 clinics, eight long-term care facilities, two assisted living facilities, five independent living facilities, five ambulance services and one research institute in four states: Minnesota, Wisconsin, North Dakota and Idaho. The health system serves a predominantly rural population whose median incomes generally fall below averages of the states where they live. The presence of our clinics and hospitals ensures that people with few economic resources don't have to drive an hour or more to receive basic (and in some cases life-saving) medical care. In addition to staffing hospitals and clinics in federally recognized underserved areas, we support the health of our communities through an active outreach program that brings specialists like oncologists, cardiologists, neurologists and others into our smaller communities. This eliminates barriers to care for many patients, particularly those who are elderly, living on low incomes, or faced with other challenges that make it difficult to travel long distances for care. Our size and integrated structure allow us to offer patients services often found only in larger urban settings. Services ranging from chemotherapy to congestive heart failure management and hospice are available to patients in many of the rural communities we serve. Essentia Health also supports the health of our rural communities through active research and clinical trials by the Essentia Institute of Rural Health. The Institute conducts clinical, translational and health services research with a primary focus on the needs of rural Americans. Essentia Health is also serving patients through the use of our electronic health record (EHR). The vast majority of Essentia's hospitals and clinics are using a fully-integrated EHR for patient care. Technology like the electronic health record and Essentia's telehealth program allows health clinicians to share test results and consult with colleagues in real time across great distances. Medical information is no longer lost in the shuffle of paper records, an important consideration in a region where patients must often be transferred to a larger Essentia facility for complex surgeries or medical care. Essentia is also actively working with government agencies and insurers to develop innovative and cost-effective approaches to care that will improve health outcomes while reducing overall costs to patients and insurers. This innovation can be found in our use of remote home monitors for patients with congestive heart failure and our focus on using a team-based approach to helping patients manage chronic diseases. Essentia Health is committed to helping patients and their families lead active and fulfilling lives in the small and large communities where they live. We hope to become a model of healthcare delivery, particularly in rural areas, in the years to come.
