WE WERE ALSO PART OF THE "RAISE THE WAGE COALITION" AND AGAIN SHARED THE ISSUE WITH OUR MEMBERSHIP AND INVITED THEM TO CALL OR WRITE THEIR REPRESENTATIVES IN SUPPORT OF AN INCREASE IN MINNESOTA'S MINIMUM WAGE. AT THE FEDERAL LEVEL, WHEN KEY VOTES WERE PENDING FOR THE FARM BILL (RELATED TO SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM) AND THE HUD ALLOCATION, WE NOTIFY OUR MEMBERSHIP AND INVITE PEOPLE TO CALL OR WRITE THEIR REPRESENTATIVES URGING SUPPORT OF THESE PROGRAMS.
