In fiscal year 2015, Plains Art Museum served 60,000 visitors (including 8,000 regional students) of all ages through high-quality art exhibitions, educational programs, and outreach activities. The Museum offers six to eight major exhibitions annually with an equal number of smaller exhibitions. The Museum's permanent collection of 4,000 objects is also used for special exhibitions and research, occasionally shown in national and international venues. Exhibitions focus on artists in the community and region. In fiscal year 2015, the Museum presented the following exhibitions: Heart/Land: Sandra Menefee Taylor's Vital Matters; Living as Form (The Nomadic Version); Sabrina Hornung: Trail Dust and Sentiment; 47 North: Daybreaks at Bad Medicine Lake by Wayne Gudmundson; FMVA Studio Crawl Preview; Art Boom: The Tri-College Art Faculty Show; Ellen Jean Diederich: Samson's Gift; In Crypt: On New Worlds Re-Ordered, An Installation by Stephen Alexander Wischer; Todd Hebert: Selected Works 1999-2014; School Spirit: Celebrating Youth Art Month; VIVID: The Art of Seth Chwast and Dietrich Sieling; Lauren Rose Kinney: Much of a Muchness; Bakken Boom!
