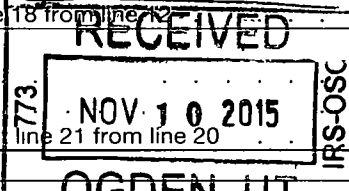

Marshall Area Christian School (MACS) served 117 students in grades preschool through 8th grade. There were 175 contact days of school for grades kindergarten through 8th grade held during the school year.
In addition to the academic curriculum for education, MACS provided:
opportunities for students to minister and serve in the community, Fine Arts February which included extra learning opportunities in a variety of fine arts areas, a dinner theater written, performed and produced by the 7th and 8th grade classes; a spring musical performed by the kindergarten through 6th grade classes; and multiple learning opportunities through various field trip events.
MACS also provided after-school learning opportunities through sports - including flag football, volleyball, and basketball. Additional after-school educational programs included science club, knowledge bowl team and speech team activities. A lunch program was provided to students on three days per week with a focus on nutrition through organic foods and local produce, such as meat, fresh vegetables and dairy products purchased directly from farmers as much as possible.

Marshall Area Christian School (MACS) offers a tuition assistance opportunity for all families of students enrolled in grades kindergarten through 8th grade. Tuition assistance is limited to 50% of tuition for all families, except families of teachers with students enrolled at MACS. For MACS teachers, there is no limit on the tuition assistance they may be granted. Tuition assistance is determined through an application made by families to an independent company. This company analyzes each families' income, expenses, assets and liabilities and determines the amount of tuition assistance each family qualifies. This company communicates the amount of assistance to MACS. To apply for assistance, the family must have paid the non-refundal registration fee to MACS as well as the application fee to the independent company. In the 2014/2015 school year, assistance was provided to 21 families providing for a total of 34 students.

During the year we provide opportunities for the students and their families to reach out to serve others. In that endeavor, offerings were given to MACS on behalf of other ministries.

These funds were paid out to domestic and international missions.
