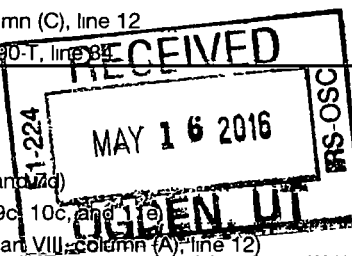

THIS IS THE FIRST TIME YOUTH TRANSITIONAL HOUSING HAS BEEN AVAILABLE IN THE WEST METRO SUBURBS, AFTER ALMOST TWENTY YEARS OF ADVOCACY. IT'S KEEPING YOUTH SAFELY HOUSED, CLOSE TO JOBS AND SCHOOL DURING A TIME OF GREAT STRESS.
