The Community Impact work of United Way includes collaborating with other organizations to develop programs and community initiatives coordinating and providing gifts-in-kind initiatives, agency program and fiscal evaluation and feedback, and non-profit capacity building and leadership development. United Way of Wapello County impact priorities include: Children are ready to succeed in school, families are financially stable and independent; Youth and adults are healthy and avoid risky behaviors. The program served 12,939 people during the fiscal year.

VOLUNTEER CENTER - Provides individual training, recruitment and placement of volunteers in our community. The Volunteer Center also implements annual Day of Action, Day of Caring and Days of Service that utilizes over 400 volunteers throughout the community. The Volunteer Center provides skill building to volunteer managers by offering a Volunteer Management Certification Program and monthly Directors of Volunteers in Organizations trainings. The program helps build the capacity of organizations to more effectively engage and utilize volunteers. The program served 695 people during the fiscal year.
