Hegg Memorial Health Center (HMHC) operates a 25-bed acute care hospital, a 60-bed nursing home, a 25-unit condominium apartment complex, a medical clinic and a child daycare center HMHC's purpose is to provide acute inpatient and outpatient services as well as residential nursing home services The amount of care provided was 770 acute inpatient days of care, 88 births, 21,725 nursing home days of care, 36,466 outpatient visits which include 5,942 home health visits, 1,695 Home Assist visits, and 20,434 clinic visits HMHC also provides 24 hour Emergency Care that provides care regardless of the patients' ability to pay There were 1,187 ER visits in FY 2015 The goal of the Community Education Department of HMHC is to offer a resource for medical issues as well as wellness promotion In December 2014, the second Frosty 5K and Merry Mile took place hosted by HMHC There were 186 participants, 7 volunteers, and 2 committee members The participants could work as a team with Christmas team costumes and could either run or walk a 5k or 1 mile This event was created to help keep the community active, even in the cold winter months In May 2015, the community education department held their second Progressive Agriculture Safety Day for HMHC 118 3rd graders participated in the event along with 34 volunteers Two coordinators were trained and certified to coordinate this event with annual continuing education Josh the Otter picked up its second year in Fiscal Year 2015 Josh the Otter teaches kids about water safety and the importance of safety precautions when in or around water This program reaches out to preschools and Kindergarten classes within the community 187 kids were able to have Josh the Otter come to their classroom to share the importance of water safety The Community Education Department offers many opportunities for the community to grow in their knowledge of medical concerns and wellness matters Hegg Memorial Health Center was recognized as the HealthStrong CAH Top 100 for the 4th year in a row The HealthStrong awards are based on The Hospital Strength Index, a national rankings program developed by iVantage to recognize top performing hospitals based on key metrics critical to success in the new healthcare marketplace The Hospital Strength Index ranks all 4,400+ U S general acute care hospitals, including the 1,300+ Critical Access Hospitals The Index is based on eight performance categories, measuring 56 different performance metrics Whispering Heights, the long-term care division of Hegg Memorial Health Center, was awarded the 2014-2015 Excellence in Action Award by National Research Corporation The Excellence in Action Award recognizes skilled nursing homes, assisted living, and independent living communities that achieve outstanding resident and/or employee satisfaction This award is especially significant because the My InnerView database is the largest warehouse of long-term and senior living satisfaction metrics in the U S Whispering Heights scored in the top 10% of qualifying facilities We are proud to receive this award as recognition of successfully measuring, improving quality, and listening to the voices of residents, families, and employees

If the patient's income is above the FPG, they are issued points depending on how much they are over the FPG. Patients are also issued points for dollar value of major assets. Points are then deducted based on the dollar amount of medical bills a patient owes. From there, the total points are calculated and used to determine the percentage of financial assistance that gets deducted from the patient's medical bill within our health center. Physicians, nurses and hospital staff presented educational opportunities for 5th grade boys and girls in the Rock Valley and surrounding areas that dealt with puberty, anatomy and self esteem issues. Babysitter Basics classes are offered each year to the youth in the community. Anti Smoking classes were given to area youth by hospital staff that touched on the importance of staying tobacco free. HANK and Friends (Healthy Active Nutritious Kids) is a program that was piloted over five years ago and has grown to serve over 800 students in grades K-5 in Rock Valley and the surrounding areas. This program focuses on nutrition and age specific exercises for children that will help to combat the increasing rise of obesity in the Midwest. Lunch and Learns were offered to area seniors focusing on topics including, but not limited to diabetes management, Occupational Therapy, proper lifting techniques, Home Health services, etc. Community Health Screenings that focused on cholesterol management as well as Diabetes Screenings were offered to community members at a reduced rate. Many other events touch on teaching the basics of certain health related issues that may either negatively or positively affect the lives of the community members that we serve. Hegg Memorial also promotes health and wellness through a 5K/10K Run/Walk and programs that focus on nutrition and obesity prevention. HMHC also hosts a Frosty 5K/Merry Mile program for promoting exercise in the winter months. A women's night out is held annually in November. More than 300 women from the community and surrounding areas attended. This event focuses on emotional wellbeing of women. A community breakfast was held for area employers and managers that addressed triggers such as stress management and drug abuse. Various employees are involved in the promotion of the American Cancer Society Relay for Life, the American Heart Association Heart Walk, Alzheimer's Association Walk, Memory Loss Support Group, and free Prenatal Classes. CPR and First Aid Classes are offered to health care workers, daycare providers, foster/adoptive parents, and the general public at a reduced cost. Various organizations request speakers from the Hegg Community Education Department. The speakers are provided at no cost utilizing the professional knowledge of our Health Center. The Community Education Department strives to offer a wide array of services at a free or reduced rate. The goal of the department is to further the mission of the Health Center through caring for others, body, mind, and soul. HMHC has a nine member board comprised of citizens that live in the primary service area. HMHC extends privileges to physicians in the immediate area. HMHC uses surplus funds to fund building improvements to enhance services to our patients. The facility completed a \$4 million project in May 2013 that added additional space for Rehab and Wellness activities. HMHC offers a 24/7 emergency department that is available to the community regardless of their ability to pay. HMHC also participates in many scholarship/educational programs. HMHC grants \$200 to two individuals annually that are planning on education in a healthcare field. HMHC also sponsors a Radiology program at Northwest Iowa Community College (NCC) so that this program can be offered in our community. HMHC offers opportunities to interns and students interested in a healthcare profession, whether bookkeeping, medical records, physical therapy, physician, etc. We also pledge \$3,000 annually to support a scholarship program at NCC. Recently, the HMHC Foundation has added on 4-5 \$1,000 scholarships to be given annually out of the Foundation funds.</p>

In turn, local caregivers are able to devote more resources to patient and resident care. Avera Health and HMHC dedicate resources to endeavors that make a positive difference to improve the health of the communities they serve. These activities include leadership development and training for community members, economic development, physical improvements in the community, contributions to nonprofit community organizations, nonprofit event sponsorships, donated medical supplies, community health education and support groups, health screenings, flu-shot clinics, community health education and various other activities.
