During the year ended June 30, 2015, the School repaid \$128,600 of principal owed on this obligation resulting in an unpaid balance due at year-end of \$1,633,758. No specific scheduled repayment of this obligation has been established. An in-kind contribution of \$17,588 has been included in support reflected on the accompanying statement of activities with a like amount included in occupancy expense for the donated interest. This calculated amount assumes an interest rate of 1 percent.
Schedule L - Parts II and IV	Since its inception the School has leased its land and certain buildings located within its campus from its Founder and member of its Board of Trustees. This lease agreement will expire on August 31, 2017, subject to a five-year extension. During the year ended June 30, 2015, the school recorded lease expense of \$134,580.
