These community care centers provide emergency assistance to families in need. These assistance services include rental and utility assistance to prevent homelessness and promote stability and safety, food pantries providing food, hygiene products, blankets, fans, and other household items, case management to ensure continued support and family empowerment.

Learning To Earning provides assistance to clients who are seeking assistance with educational enhancement or with job search needs. Included are financial coaching, education assistance for job specific training or GED, resume preparation assistance, job search assistance and financial supports such as transportation assistance, work tools or clothing, cell phones for job search or licensing needed to secure a position.
