or 30 days or shorter lengths of time. The Division doesn't place a limit on the number of times prescriptions may be refilled. We the provider identify the clients presenting problem

The Personnel Committee reviews salary and benefit trends for similar executive staff at similar organizations in Southwest Missouri. Following this review the committee reviews the evaluation with the Full Board of Directors and recommends compensation for the Executive Director for the coming year. Compensation for other key employees is established by the Executive Director and submitted to the Full Board of Directors for final review and approval.

The Executive Director or designee will assist any person requesting access to these documents by appointment. In addition, certain documents are regularly submitted to outside monitoring or oversight organizations including: minutes from the Board of Director's meetings and monthly operating income statements are sent by e-mail to our regional United Way Office; governing documents are reviewed semi-annually by monitors from the Missouri Department of Mental Health in conjunction with their certification review; policies including conflict of interest are distributed to all employees at their initial orientation session. Annual independent audits and financial reports are filed with approximately 18 external funding entities (local, state, and national).
