During FY 2014-2015, First Hand changed the lives of 1,295 children around the world by providing funding for clinical necessities (such as surgery, medication and therapy), medical equipment and travel related to care. The average grant for this time was \$1,903.

Mission-Based Grants-First Hand makes grants to other not-for-profit organizations whose work is related to our mission of directly impacting the status of a young life.
