In 2014, TFND supported the passage of state regulations on electronic cigarettes, while building public support and awareness of the health benefits of increasing the state's tobacco tax. Additionally, TFND started education and advocacy to encourage members of state health professional networks and associations to incorporate the five A's (Ask, Advise, Assess, Assist, and Arrange) into their patient visits.
