Hope Street Group is a national nonprofit, nonpartisan organization dedicated to expanding economic opportunity and prosperity for all Americans

In 2003, on South Hope Street in Los Angeles, CA, a group of young entrepreneurs, business, and technology professionals concerned with individual and national economic opportunity in the U.S. formed Hope Street Group. This group believed that by infusing diverse understanding and expertise into economic challenges, we could dramatically improve access to opportunity. Since our founding, we have worked diligently to apply this model and incorporate the application of innovation and technology to the education, health, and jobs sectors. Our Impact: Our work has significantly impacted education policy and teacher practice. Through Hope Street Group's education initiatives, we offer an opportunity for policymakers and educators to work together to significantly improve the way public education operates at the national, state, and local levels. We have seen that by creating structured programs and leveraging the model of the Teacher Fellow Programs through cross-learning and communications, we can streamline challenges and scale solutions between various education stakeholders. In addition, our network provides access to individuals who offer unique, new, and on-the-ground perspectives that could potentially become viable solutions to public policy problems. Hope Street Group offers a safe place to test those solutions and to pilot new ideas.

4b (Code) (Expenses \$ 701,515 including grants of \$) (Revenue \$)

We have launched our Sync Our Signals (SOS) Initiative working to re-engineer the jobs marketplace by 1) facilitating employer transitions to competency-based sourcing, selection, and hiring practices, and 2) signaling to the learning community what those competencies are and how to supply them to individuals, and 3) empowering individuals, through informed learning, with better access to tools and innovation. To advance this mission, Hope Street Group is serving as the backbone organization of an integrated approach involving multiple entities across the components of demand, supply, and the marketplace. In addition, Hope Street Group is working with foundations and partners to build communities of practice. For example, Hope Street Group is leading a new collaboration with Walmart to harness the shared learnings of key organizations in retail and adjacent sectors. The Community of Practice will help integrate and advance the work of grantees within the Walmart and Walmart Foundations Opportunity Initiative and other related workforce efforts.

We are reorienting care toward prevention, wellness, and active disease management. Our national policy-level work, as well as our ground-level pilot program work, has influenced and informed numerous conversations on health in the United States. We've moved from discussing ways to make healthcare more affordable to addressing the underlying causes of preventable disease. We are currently working diligently on planning new convenings and forming new pilot program initiatives to delve even deeper into this issue and to uncover innovative approaches for cross-sector widespread change.
