CATHOLIC CHARITIES REFUGEE AND IMMIGRANT SERVICES HAVE RESETTLED REFUGEES IN THE INDIANAPOLIS AREA SINCE 1975. WE HAVE 40 YEARS OF COMMITMENT TO PROMOTING HUMAN DIGNITY BY ASSISTING REFUGEES' TRANSITION TO A NEW COMMUNITY. OUR COMPASSIONATE SERVICES EMPOWER REFUGEES TO ACHIEVE SELF-SUFFICIENCY.

RECEPTION AND PLACEMENT SERVICES ASSIST REFUGEES DURING THEIR FIRST 30 DAYS IN THE COUNTRY. SERVICES INCLUDE: AIRPORT PICKUP AND TRANSPORTATION, SAFE AND SANITARY HOUSING, INCLUDING ESSENTIAL FURNISHINGS, FOOD, CLOTHING, ASSISTANCE APPLYING FOR SOCIAL SECURITY CARD, WORK AUTHORIZATION, HEALTH SCREENINGS AND OTHER NECESSARY APPOINTMENTS.

ONCE IN THE RECEPTION AND PLACEMENT PROGRAM, REFUGEES CAN APPLY FOR THE MATCH GRANT. IF ELIGIBLE, THEY ARE PROVIDED WITH EXTENDED RESETTLEMENT SERVICES FOR 90 TO 120 DAYS. HOLY FAMILY SERVICES HAS TWO PROGRAM COMPONENTS: HOLY FAMILY SHELTER AND HOLY FAMILY TRANSITIONAL HOUSING.

HOLY FAMILY SHELTER, AN EMERGENCY SHELTER FOR HOMELESS FAMILIES, ADDRESSES THE INCREASING DEMAND FOR EMERGENCY SHELTER IN INDIANAPOLIS AND CENTRAL INDIANA BY PROVIDING RESIDENTIAL SERVICES DESIGNED TO MOVE HOMELESS FAMILIES TO SELF-SUFFICIENCY.

HOLY FAMILY TRANSITIONAL PROGRAM PROVIDES HOUSING AND SUPPORTIVE SOCIAL SERVICES TO HOMELESS FAMILIES ONCE THEY HAVE MOVED OUT OF THE EMERGENCY SHELTER. THIS PROGRAM PRIMARILY TARGETS HOMELESS FAMILIES WHO FACE THE MOST COMPLEX CHALLENGES AND HAVE SERIOUS, PERSISTENT ISSUES THAT CAN QUICKLY LEAD TO FALLING BACK INTO HOMELESSNESS IF NOT SUPPORTED. THE COMBINATION OF HOUSING AND COMPREHENSIVE CASE MANAGEMENT HAS PROVEN TO BE A COST-EFFECTIVE WAY TO HELP HOMELESS FAMILIES MAINTAIN PERMANENT HOUSING WHILE LIVING A MORE STABLE, PRODUCTIVE LIFE.

THE MISSION OF A CARING PLACE ADULT DAY SERVICES, CATHOLIC CHARITIES INDIANAPOLIS, IS TO PROVIDE PERSON-CENTERED-CARE IN A SAFE AND STRUCTURED ENVIRONMENT WITH THERAPEUTIC AND MEANINGFUL ACTIVITIES FOR OLDER ADULT WHO REQUIRE SUPPORTIVE AND SUPERVISED SERVICES DURING THE DAY, WHILE PROVIDING ASSISTANCE TO CAREGIVERS, SUCH AS, EDUCATION, MINOR HOME MODIFICATIONS AND REFERRALS TO APPROPRIATE AGENCIES, AND RESPITE SUPPORT TO CAREGIVERS, KEEPING THE PARTICIPANTS ACTIVE IN THE COMMUNITY AND DELAYING INSTITUTIONAL CARE.

FOUNDED IN 1990, AFTER A SURVEY IN THE BUTLER-TARKINGTON AREA INDICATED A NEED FOR SERVICES TO THE ELDERLY IN THE AREA, THE PROGRAM WAS TOTALLY SUPPORTED BY THE CARING COMMUNITY. IN 1992, CATHOLIC CHARITIES INDIANAPOLIS BEGAN TOTAL MANAGEMENT, INCLUDING FISCAL RESPONSIBILITY AND HAS OPERATED OUT OF THE FAIRVIEW PRESBYTERIAN CHURCH ON NORTH CAPITOL AVE.
