Tribal Gathering is our main program and it is the hub where the rest of charitable projects with the indigenous communities invited are forged. Once a year we bring together indigenous people from over twenty countries from five continents to partake in Tribal Gathering. It's an 18 day international gathering on a beach in the Caribbean, attracting paying attendees from more than forty countries. In 2015 we had around 600 participants that benefited from it. Indirectly, its reach is a lot bigger through the consequent projects performed with the communities partaking. The tribespeople run workshops, presentations and rituals on various aspects of indigenous art and culture to share with the other fellow tribes and with the international audience. Other non-indigenous also run workshops throughout the event to educate the general public on environmental and social issues, nutrition, health, sustainable development, etc. There are two music stages with international artists performing eclectic, global and electronic music and a plethora of art installations and exhibits all to pursue the understanding and appreciation of art by the general public. This event will eventually become the main fundraiser for our charitable projects. Once the event is financially sustainable, which we foresee will happen in the 2018 edition, we will train and hand it over to a management team that involves (Continued on Schedule O, Statement 4)

INTERTRIBAL SYMPOSIUM USTUPU - GUNA YALA (SEP 2014) The purpose of the Intertribal Symposium Ustupu - Guna Yala was to grant tribes from different locations and backgrounds the opportunity to come together sharing their artistic creativity with each other allowing them to partake, educate and grow with one another through cultural exchange presentations, interactive workshops, dance, celebrations and more to inspire cultural preservation and growth. We brought together members of six different tribes from Panama, Costa Rica, and Guatemala to Guna Yala to offer publicly available classes encouraging the interaction with the general public both foreign and local. Engaging everyone to learn traditional weaving, wood carving, jewelry making, chocolate processing and marketing, cooking and more through the same hands on workshops. We had also taken the opportunity that this visit to Guna Yala provided to deliver a few donations to some of the island native communities. 120 adults and children participated in the activities.

INDIGENOUS FORUM @ UNITED NATIONS (April 2015) Geoparadise sent Lourdes Frasser Rojas, from the Asociación Cultural So Cagré (Boruca tribe in Costa Rica), and Kity Peña Conquista from the Asociación Agro-etno-turística Wounaan (Panama), to the 2015 United Nations Indigenous Forum in New York City. Each member got the opportunity to speak to the other attending members of the United Nations about their communities and the challenges they are facing. They also had the opportunity to hear about the other Indigenous attendees' communities. Geoparadise supported 2 women for this project who are leaders in their communities. They could return home and tell their communities about what they had learned from the global knowledge that was learned at the forum, and the solutions that they learned to overcome the issues their communities faced. It also opened a network of worldwide connections and an insight of the inner workings of the UN institutions and how to potentially find help and support for their communities through said network. The project is in relation to the mission statement whereas the project educates and informs members of the general public about health, nutrition, environmental, and social issues, which are the problems the tribes are facing nowadays because of malnourishment, deforestation and community loss due to logging and mining companies

For 2014/15 tax year things did not work out timely for the following reasons At the end of October 2015 we had one of our 5 permanent team members (Jeffrey Ray Hallock) going back home to the USA after going through a period of erratic behavior, haven't shown the ability to focus and get the work done He had around 40% of the paper bills from the tax year 2014/15 under his care and was supposed to be working on the data entry in the summer and fall when not busy with any charitable mission He was also managing several of these projects and in charge of producing a report for each of them, including the financial reports These are Intertribal Symposium in Kuna Yala in Sep 2014, Donations to Kuna Yala in Nov 2014, Boruca indigenous heritage workshop in June 2015, Boruca cooperative art supply store in July 2015 and the Kamayura community meeting hall (brazil) in August-Sep 2015 Unfortunately, after he returned to the USA in October 2015 we have never heard back from him again He deleted his Facebook account, did not respond to any emails and nobody knows where he is This has caused a tremendous amount of extra work to the remaining members on the team, having to look for the receipts in the office he was using, some of which were in very bad condition making them really hard to read, plus also having to analyze emails, facebook, text messages and whassap conversations to try discern what happened during those projects, what each receipt was for, etc We also had to interview the indigenous people he had worked with during the projects he was in charge of, to understand the expenses and be able to report them properly As a result of the former member's refusal or inability to complete this work, extended inaccessibility of the receipts and other documents under his control, and necessity of recovering and regenerating said documents, its was not possible to timely submit Form 990 for the tax year 2014-2015
